Officer & Staff Reports

• President – Welcome all. Moving through tonight's agenda, we do have a couple items to discuss, and we'll take as much time as we need.

Many soccer events have taken place since NCASA last met. Champion of Regions; there was an unfortunate incident with our Over 40 team who fielded an ineligible player. We will learn more about that in our Competition report.

The Registration Committee needs to meet. Laura Collins has submitted a proposal for the committee to consider. Committee meeting requests will go out.

The registration numbers look good, and we will hear more from our registrar.

Executive Director – Attended the National Amateur Cup for Men and Women in Chicago.
 Both Region III teams, Tobacco Rd. FC and Winger FC are NCASA teams.

The teams represented NCASA and Region III very well on and off the field. Tobacco Rd FC were knocked out by Region I NY Pancyprian Freedoms in the semi-final and the Winger FC lost to Region IV Pan World Women in the Championship.

The very next weekend, Queen City Cup took place. Cindy managed the rostering and NCASA took all our tournament gear to assist with the event.

NCSRA invited the youth director and me to speak for a few minutes at a high-level NC Referee meeting. It gives NCASA an opportunity to speak directly to officials about NCASA and the Carolinas Cup.

NCASA had three teams win their division at USASA Region III Championships in the Amateur Men and Women divisions and the Over 40 Men's division. Cindy worked closely with each team to ensure proper rostering.

Conversations with Ava Lynch, who lives in Winston-Salem and is USASA's social media manager, about assisting NCASA and our projects. Cindy shared links to all of NCASA's accounts for Ava to get an understanding of who we are. We will be holding talks to go over goals and strategies to achieve our objectives.

NCSL is an ongoing focus.

Cindy, Donna and TeamPass are reviewing opening registrations earlier to combat tournaments requiring earlier registrations. Our goal is to allow players to register earlier in NC to avoid purchasing out-of-state single event or annual passes.

Still mapping a Discipline and Appeals Manual. USSF has expanded the abuse definition in Policy 591-9 which is Misconduct Towards a Game Official.

Executive Vice President – I've been working with the office on more operations; spending time
with Cindy and Darius working on registration, database and TeamPass. Also working on state
processes such as D&A and how it impacts.

Hummer in the Summer tournament needed assistance running the tournament registration through TeamPass for the first time.

 Treasurer – Gave a summary of NCASA finances. NCASA is in a positive financial position. Details are in the Treasurer's report.

Growth Initiative

Registration Report – Registration is robust. Fall season is kicking off and registration is increasing. We are on track for another stand-out year. Many leagues have already surpassed their 2023 numbers-- Metrolina, TASL, OCASL, WASC and Wake Women. Several other leagues are very close. Fall registration has just opened for many of our leagues. The numbers for the registrar report were taken from early August numbers; our September and October report will reflect most of the Fall growth. Our single event passes are significantly down from last year due to Beer City Cup affiliating directly with USASA. NCASA is selling more Annual Passes instead of single event passes. As of Aug. 13, there were 457 annual passes. These players are not associated with a league. The state is a mid-size league on its own.

- First Year Leagues Update Transylvania Adult Soccer Association continuing to register players.
- New League Update GCCSA vice-president Rosanna Faulkner contacted the NCASA regarding affiliation. GCCSA is a youth club west of Charlotte.

Competitions

- Carolinas Cup Registration is opening September 1st. Scott Eisenbraun has been working to secure a sponsor. The Cup Committee will be meeting soon.
- Celebrate the Tatas –Registration is positive, shirts, party hotel and other details are on track. Additional food vendors are needed. US Soccer has committed a wonderful Fan Package to raffle off. The event is on Cindy Parlow Cone's calendar; doesn't secure her attendance but there is a possibility.

- USASA Adult Soccer Fest NC teams that attended the USASA Soccer Adult Fest should be receiving a refund for part of their entry fee. Inquiry to USASA when the teams are to receive their refunds.
- USASA Amateur Cup The NCASA teams represented very well on and off the field. The venue was Husky Stadium, Northern Illinois University, which is a soccer specific facility. The event was a bit lacking in atmosphere with very little team fans.
- USASA Champions of Regions Scott Eisenbraun represented NCASA at the Amateur Cup and Champions of Regions. The NC Wanderers FC competed against Central Park Rangers from Region I. Very exciting match that saw 6 lead changes through double overtime. Wanderers FC prevailed in PKs that saw each keeper save a shot in the first five taken. Game was decided 8-7 when Wanderers FC keeper saved the 8th pk.

Wanderers FC had a guest player that had trained at the Barcelona Youth Academy and had several years at the professional level with other teams. This player's career steps is online. An opponent looked him up and verified the player was under 40 and did not meet the age requirement to compete in the Over 40 division. The player uploaded a photo of his passport for his government issued ID. Upon scrutiny, the passport upload was doctored to an older birth year. The manipulated information did not match the passport code on the bottom that displays country of birth, dob and date the passport was issued. As a result, Wanderers FC were disqualified. Central Park Rangers defeated Region II Torino FC for the Championship.

- Queen City Cup 2024 QCC was a bit smaller than last year. The event lost several
 contributors to the operation, putting many tasks on a few. The participants are loyal and
 returning teams and really enjoy competing. Next year is the QCC 10th anniversary and
 the plan is to build the excitement and put on a big show.
 - QCC continues to hold a Charity Division; it is the most attended division where the Champion's prize money goes to the charity of their choice.
 - Really appreciate the support from NCASA with roster, and equipment. Truly contributes positively to the event and adds legitimacy, it helps to connect members to the state.
- Beer City Cup Asheville Tournament is in good shape with staff, divisions, schedule and complex. 132 teams maximizing all the complexes in Asheville.

Organizing Committees

 D&A Committee – In Feb. 2024, USSF began reviewing the USSF Policy 531-9 which is Misconduct Towards a Game Official. In May, the US Soccer BOD ratified the amended policy. There are significant changes to the policy that will impact on our state processes and league practices.

Now players accused of referee abuse will be automatically suspended until the outcome of the hearing. USSF have also expanded the abuse definition to go beyond simply communication of a threat. There are definitions under Gross Mistreatment, which includes discriminatory language around gender, race, ethnicity, sexual orientation, disabilities or any other legally protected characteristics. The policy touches on several other areas. It is important that these changes are communicated clearly to our members and leagues.

• Scott Eisenbraun – In discussions with Salem City FC, the USL Pro 2 team that would like to learn more about sponsorship opportunities at the Carolinas Cup. Truist Park, where the Carolinas Cup is held, is also the home field for the Salem City FC. Salem City FC is also exploring the idea of having an amateur team enter the Carolinas Cup. Strong potential to secure sponsorship for the Cup and land an elite amateur team.

Update – The league start date was intended to be August 18th. NCSL held a match between Say Word FC and Medicine City in a friendly. Unfortunately, the NCSL has not had the team registration it had hoped for. Over the summer, especially after the TST event, several teams expressed interest in joining that didn't materialize by our deadline. Currently, Say Word FC and Central Raleigh are the two committed teams. There are another 4-5 captains that Darius will be meeting with to discuss joining and then re-shuffle the schedule.

Cedric Burke is our chairman, and he is committed to the project. The league needs a strong committee to form and become active on two fronts, salvaging the Fall 24 season and looking forward to 2025.

Carolinas Cup Budget

Whereas the Board approved a policy at its February 21, 2022, meeting requiring the Carolinas Cup committee to present to the Board for approval a proposed budget describing how funds already budgeted in the annual budget for the Carolinas Cup are expected to be spent no later than three months before the start date of the Carolinas Cup tournament;

Whereas the Budgetary Spending Authority Policy allows the Carolinas Cup committee to expend funds beyond the budgeted funds up to the amount of revenues from the event, and

Whereas the August 19, 2024, NCASA Board meeting is the final Board meeting occurring more than three months before the start date of the Carolinas Cup tournament,

Be it resolved that the Board authorizes the Carolinas Cup committee to spend \$66,000, consisting of the already budgeted funds of \$52,500 plus an additional \$13,500, with the additional spending primarily paid for by additional revenues from the event (e.g., additional registration fees, sponsorships, and donations, including in-kind donations), in a manner consistent with the following proposed budget:
